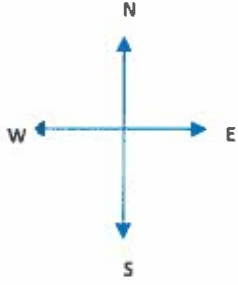
The purpose of this notice is to inform the neighboring landowners and the public of the nature of the application and of future notification and appeal rights.

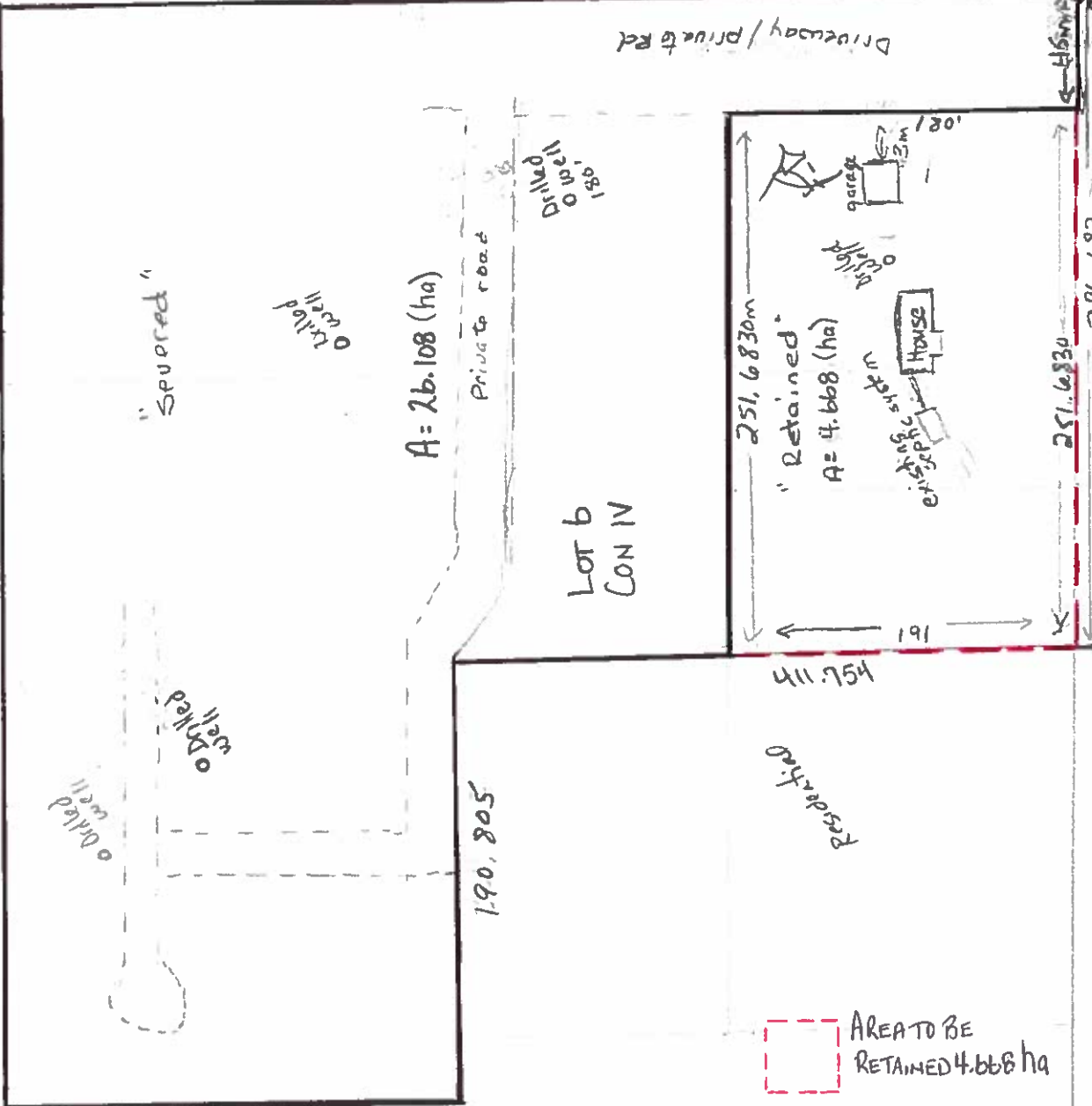

If a person or public body that files an appeal of a decision of the Township of Dorion in respect of the proposed consent does not make written submissions to the Council of the Township of Dorion before the Council gives or refuses to give provisional consent, the Local Planning Appeal Tribunal may dismiss the appeal.
